In or around September 2009, CCE was recommended by civil contractors, Gary Deane Constructions, to assist with the engineering design and supervision of a partial track upgrade of Albion Park Raceway. I prepared a fee proposal and CCE were commissioned by Harness Racing QLD before they were amalgamated into Racing QLD. The design was completed in Oct-Nov 2009 and I recall that the construction was a brief 2-3 week period in January 2010
- 6.
