
1. I refer to my affidavit sworn on 5 August 2013.
2. In paragraph 6 of my affidavit, I swore:

*"Further, as at the date of affirming this affidavit, Crown Law have not yet responded to a number of the requests for documents made by my solicitors".*

3. Annexed to my affidavit and marked "AF-9" was a copy of a table outlining the documents that had been requested by my solicitors and the documents that had been received by them ("the Table").
4. At the time of swearing my affidavit it was my belief based on discussions with my solicitors that Crown Law had not responded to a number of requests for documents. However, my solicitors have since informed me that Crown Law did respond to all but one of these requests. The request that Crown Law had not responded to by that time concerned a request for a complete copy of the briefing notes provided by RQL to me between September 2006 and March 2009.

- a) A complete copy of the briefing notes provided by Treasury to me as Deputy Premier, Treasurer and Minister for State Development and Trade dated 10, 14 and 17 February 2012;
  - b) A copy of the emails exchanged between Treasury and RQL concerning the payment of funds by Treasury to RQL in February 2012;
  - c) A copy of the briefing notes provided by RQL to me between September 2006 and March 2009 concerning the annual reports of the three industry bodies; and
  - d) A copy of a Cabinet Note relating to the revised Industry Infrastructure Plan dated 30 January 2012.
6. I also wish to clarify the last entry on the Table. In relation to this entry, the request made by my solicitors was responded to by Crown Law and a document was provided, however it was not the correct document and clarification of this by my solicitors may have resulted in the complete and correct document being provided.
7. I am also informed by my solicitors, and verily believe, that since swearing my affidavit further documents have been provided by Crown Law, namely briefing notes relating to the control body approvals for Qld Harness Racing Ltd and Greyhounds Qld Ltd.
8. All the facts and circumstances deposed to in this my affidavit are within my own knowledge and belief, except for the facts and circumstances deposed to from
